I further understand that ICON will discontinue sending me statements via postal mail service and the current statement information will be available by the 5th day of each month. I may occasionally receive additional messages from the credit union.

#### Right to Withdraw Consent

I may withdraw my consent and terminate this Agreement at any time by notifying you in writing at the address above, or by electronic means at [contact@iconcreditunion.org](mailto:contact@iconcreditunion.org). I agree to allow you a reasonable time to resume providing disclosures and other information covered by this Agreement in written form. There are currently no conditions, fees or other restrictions relating to my withdrawal of consent. However, you reserve the right to impose such conditions, fees or other restrictions at any time upon such notice as may be required by law.

#### Updated Contact Information

If I change my e-mail address, Internet Service Provider or other information needed to contact me electronically, I must provide you with updated information by written notice sent to the address above or by electronic notice to [contact@iconcreditunion.org](mailto:contact@iconcreditunion.org).

#### Hardware and Software Requirements
